Dear resident,

The Ontario government has released an alarming plan to spur sprawl across Southern Ontario, at the expense of municipalities, democracy, farmland, and bold action on climate. Here's the plan.

Premier Ford is green lighting the construction of 50,000 homes on 7,400 hectares of Greenbelt. It doesn't look good that some of this farmland is owned by developers who donate big to the PC party.

The Conservatives are rewriting municipal official plans to permit development on nearby farmland. The government just overrode Hamilton City Council's smart and sustainable official plan to meet growth needs by increasing density within areas already zoned for development. Hamilton's plan should be lauded as an archetype, not mauled.

The government has also introduced Bill 23, which gets scarier every time I read it. Bill 23 weakens

Toronto's landmark inclusionary zoning law. Inclusionary zoning requires developers to build a percentage of affordable homes in all big buildings near transit stations. Developers will be exempt from paying development charges on these homes if they meet a very weak definition of affordability. A home sold for \$880,000 is now considered "affordable". Mayor Tory has warned the province the developer fee cuts will leave a gaping \$200 million hole in its budget, to be filled by service cuts or tax hikes.

Bill 23 also restricts conservation authorities from advising on developments that threaten our natural environment, and bans just about everyone but the municipality and a developer from appealing a project to the Lands Tribunal. We get less say.

On the positive side, Bill 23 makes it easier to build more homes in neighbourhoods. The bill requires all municipalities to pre-zone areas near transit stations for higher density, and permits three homes as-of-right on each residential property. Municipal approval is required to increase the property's height or square footage.

Ontario's homelessness and housing affordability crisis will not be solved by letting the market solely decide where and what to build, and who for. To ensure every Ontarian can live in a safe and affordable home, the province should build far more homes, including townhomes, duplexes and triplexes, invest in building affordable homes, clamp down on domestic and foreign speculation, and bring in better protections for renters. I urge you to contact myself, Premier Ford and Housing Minister Clark to share your perspective on these housing issues. Please reach out if you have feedback, comments, questions, or need help.

I am delighted to take up my post as City Councillor for Ward 11. Thank you to the residents of North Rosedale who showed great support to my municipal campaign. I had many conversations at doors in your neighborhood and voter turnout was strong here despite many other voters staying home across the city. On election day, I spent a beautiful, sunny morning in the area with my volunteers.

Over the coming weeks, I look forward to establishing a regular cadence of meetings with the NRRA and other Rosedale associations to discuss issues of local concern.

One of the most pressing issues is the 120+ development applications that are pending in Ward 11. As we build housing, no one neighbourhood should be overwhelmed, and my office will work to minimize construction disruptions from those projects which are already approved. New applications will be treated individually, with development proceeding hand in hand with community consultation. I look forward to learning more about the countless volunteer hours that have gone into protecting the heritage character of North Rosedale.

That said, the Ford government has already cut the development charges that pay for community benefits like parks by 40%, and its Bill 23 will reduce them further. Unless amended, Bill 23 will also do great damage to the city's ability to protect tenants, trees, heritage buildings and neighbourhood character, and to enforce its Toronto Green Standards. We will be looking closely to see the impact of the final Bill and its regulations.

Another pressing issue in the ward is the need to preserve and enhance local trees and green space. In Rosedale, the wealth of parks and ravines benefit all Torontonians, but they urgently need attention to combat flooding, erosion, and invasive species. Metrolinx' regrettable layover plan will do significant damage, some of it destroying the hard work of volunteers devoted to ecosystem restoration.

I'm concerned about the impact of Toronto Hydro's upgrade plans on local tree cover and tree health, especially as the climate crisis makes street trees ever more valuable and threatened.

I am also awaiting a briefing from city staff on the explosion of homelessness that has led to a growing number of tents in the Rosedale Ravine, and what the city can do about it.

My constituency office and I will also be working on your street-level concerns such as road safety. It is unacceptable that so many lives are lost or ruined due to poor road and intersection design and excessive speeding. Children, seniors, and those with mobility issues should not have to be afraid to cross the street.

I look forward to working together with you on these, and other, issues of concern and I promise to be a regular contributor to the NRRA newsletter. 

# Let's Protect Lower Don Valley Green Space

The NRRA continues to follow developments in connection with the proposal by Metrolinx to build a parking facility for diesel GO Trains on the east side of the Lower Don Valley. The NRRA believes that our ravines—including the Don Valley—are essential to Toronto's identity and play an increasingly important ecological and cultural role in our available green spaces. To date, Metrolinx has not made the case that its layover capacity requirements need to take up Don Valley greenspace, nor have they provided alternatives that could possibly meet their needs. More bluntly, the proposed layover would disfigure one of our City's most iconic locations, while destroying habitats and tree cover. Protecting urban nature and improved transit are both critical to our future; it shouldn't be a choice between the two. Along with other residents' associations and environmental groups, the NRRA signed an open letter to Metrolinx in June requesting that the layover plans be reconsidered. City Council passed some related resolutions in the summer, instructing the City's Transit Expansion Office to explore other options with Metrolinx. Councillors Paula Fletcher (Ward 14) and Mike Layton (Ward 11) took a lead role in mobilizing Council's engagement on this issue; we look forward to raising it with our new Ward 11 Councillor Dianne Saxe, who will bring a highly informed perspective to this issue as the former Environmental Commissioner of Ontario.



We encourage North Rosedale residents to take an interest in this issue. Additional information is available on the websites of Metrolinx (www.metrolinx.com) and of the Build the Park group, which continues to mobilize opposition to the layover (www.buildthepark.ca). Also please explore Build the Park's self-guided tour, which follows the Lower Don Trail south from Pottery Road and points out many aspects of the potential impact of the proposed layover on the Lower Don Valley.


# Downspout Disconnect


# Did you know:

- By disconnecting your downspout, you help your neighborhood's sewer system and the City of Toronto's storm sewers from overloading during heavy rain.
- Go Green! By disconnecting your home's downspout, you can re-route water directly to your lawn, garden, or perhaps into a rain barrel for later use, which saves both water and money.
- Diverting your downspout away from your home's foundation helps reduce the risk of basement flooding.
- And, did you know there are program that offer eligible households financial assistance for downspout disconnection, where some costs could be reimbursed.



# For Me, Rosedale Is Personal

Picture it! In my memory it started for me when I was very young. My Mum, Jane would drive us to Great Grandfather Strathy's house on Castle Frank Road which he built in 1911 and named "Inchaffray". This was the time when children were supposed to be seen and not heard. Inside this terribly grand house was a long... a very long hallway with a honeycomb ceiling and at the end was "a gong. The wonderful and often challenged housemaids; Mabel and Gertrude would sound the gong to announce dinner... As a wee one this "gong bong" was a magnificent opportunity to display my creative spirits and musical talents, This might have curbed my future opportunities to return to the house. But! It must be noted that my mother's generation also engaged in some high-jinks as they battle it out under the Dining table with water guns. Fun could also be found in the Ballroom on the third floor, which is now a discotheque, and did I mention there was a tunnel underneath the house that led to the Coach House. Recently, my step-Mother ensured I received a massive sterling silver tray from the Chestnut house. Yes! I do, in fact love my stepmother! Now where was I? Oh yes, this tray is so big (we are talking pork size), I wish I had known about it as a University student as we would have used it as a toboggan at Chorley Park. And,... if we'd been caught, we would have blamed the house maids for any dints. Oh, the poor house maid so often blamed for everything!

So, the moral of my story... Rosedale is personal. Rosedale is constant. Rosedale continues on for everyone. The past, present and future will always have grand stories about Rosedale. I know Rosedale as a wonderful place to live, laugh, love and frolic... just don't tell Alice, Mabel, or Gertrude!

# North Rosedale Continues To Work with The Toronto Nature Stewards

The Toronto Nature Stewards' site at Roxborough Parkette continues to see a good turn-out of volunteers, each Monday evening this year from May through October. The group has been making good progress in removing invasive species such as garlic mustard, Japanese knotweed, dog-strangling vine, and common buckthorn, making room for native plants to thrive, such as jewelweed, white avens, goldenrod and dogwood.

Promoting native species while managing invasives is an equally important challenge on private property, especially with the abundance of ravine lots in North Rosedale. Homeowners are encouraged to check out the information focused on private property owners provided by Toronto Nature Stewards:

There are a few quick and easy things we can all do to promote biodiversity and help nature. Although we are blessed with ravines and lots of green space, we do need to look after it.







# ROSEDALE'S FINEST - RECIPE OF THE SEASON



# INGREDIENTS

- 5 tbsp extra-virgin olive oil
- Thick slices of pancetta (4 oz), cut into ½ inch dice
- -1 medium onion, ½ inch dice
- -1 lb dried flageolets or Great Northern beans, rinsed and soaked for 2 hrs and drained
- 4 thyme sprigs
- 2 quarts water
- -1 quart chicken stock
- -1 large head of garlic, separated into cloves and peeled
- Kosher salt
- 4 pieces of duck leg confit, trimmed of excess fat
- 3/4 lb garlic sausage, sliced crosswise  $\frac{1}{2}$  inch thick
- 4 oz lean slab bacon, cut into 1 inch cubes
- 2 cups coarse fresh bread crumbs
- 2 tablespoons chopped parsley



# Duck Confit Cassoulet

# METHOD

- 1. In a large saucepan, heat 3 tbsp of the olive oil. Add the pancetta and cook over moderate heat until the fat has been rendered, approx. 5 minutes. Add the onion and cook, stirring occasionally, until softened, approx. 7 minutes. Add the beans, thyme sprigs, water and stock and bring to a boil. Simmer over low heat, stirring occasionally, until the beans are all dente, approx. 1 hour.
- 2. Add the garlic cloves to the beans and simmer until the garlic and beans are tender, approx. 15 minutes. Discard the thyme sprigs. Season the beans with salt and let cool to room temperature. Cover and refrigerate the saucepan overnight.
- 3. Preheat the oven to 350°. Rewarm the beans over moderate heat. Transfer the beans to a large, deep baking dish. Nestle the duck legs, garlic sausage and bacon into the beans. Bake for approx. 40 minutes, until the cassoulet is bubbling, and all of the meats are hot. Remove from the oven and let rest for 15 minutes.
- 4. In a skillet, heat the remaining 2 tablespoons of olive oil. Add the bread crumbs and cook over moderately high heat, stirring, until browned and crisp, approx. 3 minutes. Sprinkle the bread crumbs and the parsley over the cassoulet and serve.
